<ul> <li>is agreement entered into voluntarily by and between the above customer, whether single or plural, are Olive Volunteer Fire Department (hereinafter referred to as OVFD). The parties agree as follows:</li> <li>The customer tenders OVFD the sum of \$144.00 for an annual fee. The receipt of which is hereby acknowledged. The customer should make a copy of this agreement.</li> <li>The customer is responsible for the return of this agreement and payment to OVFD which will make the agreement valid upon OVFD receipt.</li> <li>OVFD agrees to respond when available to the premises described above in accordance with OVFD Standard Operating Guidelines.</li> <li>Neither OVFD nor any agent or servant thereof assumes any liability or responsibility to the customer and shall not be responsible for claims of any nature arising out of this agreement.</li> <li>The customer shall be solely responsible for renewing this agreement upon its annual expiration date from the date received by OVFD.</li> <li>This agreement can be terminated by the customer or OVFD at any time for any reason and subject to change without notice.</li> <li>Per Oklahoma Statute Title 36 Section 4809 insurance companies may give special or reduced rate for fire insurance in rural areas if the customer is subscribed to fire dues and by providing them proof of this agreement. The customer understands the insurance company may have policy provisions in place to reimburse the costs associated with the emergency response and the OVFD may attempt to recover such funds and the customer will not have any out-of-pocket expense if the insurance company refus to pay. Any insurance payments received related to OVFD services rendered must be delivered to OVFD.</li> </ul>
<ul> <li>Hazardous materials response involving the release of any hazardous materials from its container that has the potential to harm persons, property or the environment is not covered by this agreement.</li> <li>If the customer conducts a prescribed/control burn and the burn becomes out of control, the custom</li> </ul>
hereby notified he/she will be charged for fire response if the burn is not reported per Oklahoma Statute Title 2 Section 16–28, and/or done on an elevated fire danger/red flag warning issued by the National Weather Service, and/or during a county/state declared burn ban, and/or found guilty under any Oklahoma Unlawful Burning/Arson Statutes.
